## Running the District ...

Happy New Year! I hope that you and your family have had a wonderful (and safe) holiday season.

The beginning of a new year is a great time to reflect upon what has happened over the past year, as well as to make plans for the new one. Many, if not most, of us establish goals for the new year. Personally, as each new year begins, I prepare a set of written goals for the new year, as well as strategies to achieve them. Now is a great time to "take stock", then plan for the future.

In part because so many of us are reflecting and planning, Rotary has designated January as Rotary Awareness month. It's a great time to remind ourselves of how Rotary fits into our lives, as well as an especially good time to make others aware of what Rotary is and what it does.

Why is it so important to build awareness of Rotary? First, it is great way to build interest and support for the projects that your club does. Too often, people even in our own communities aren't aware of the great work done by Rotary. We need greater awareness of what our clubs are doing in each town and city. Building awareness is a great way to

build support for your club's fundraisers and projects. Second, we need greater awareness of what the Rotary Foundation is doing. When people learn what the Foundation is doing, they're more likely to support it. Third, building awareness may lead us to local leaders who we might want to invite to be members of our clubs.

So what can and should you do to increase awareness? The simplest thing is to wear your Rotary pin, as well as Rotary-themed clothing (e.g., golf hats, shirts, sweatshirts, and ties). Let everyone know you're a Rotarian ... and not just on the day of your Rotary meeting. A great reason to do this is the opportunity to strike up a conversation about Rotary with someone who doesn't know about it. Answering the question, "what's that pin you're wearing?", is a great starting point for increasing awareness of Rotary.

Similarly, consider wearing a "Stop Polio Now" pin. Given that we haven't had a case of polio in the USA in over 30 years, polio is pretty much "off the radar" for the average person. Your "Stop Polio Now" pin/button is a great way to start up a conversation about polio ... and Rotary.

So what do you say when somebody actually does ask you about Rotary? Unfortunately, if you're like most Rotarians, you tend to stumble at this point. That's why every Rotarian should have what's called an "elevator speech", so named because it is a description you can provide in less time than it takes to ride an elevator. Let me share my Rotary "elevator speech", what I say when somebody asks me what Rotary is:

Rotary is a global network of 1.2 million business, professional and

community leaders transforming lives both near and far. We meet in some 34,000 clubs in nearly every country in the world. We're leading the effort to eradicate polio worldwide, and have almost completed the task, as well as tackling important problems in nearly every local community in Florida and the rest of the USA. I've been a member for 20 years and have found it to be immensely rewarding. What else can I tell you about us?

If you like this, you're more than welcome to plagiarize! In any event, come up with your own "elevator speech".

You can increase awareness by inviting a guest to attend a club meeting this month. Make a point to invite a business, professional, or community leader you know to attend this month.

You can also increase awareness by inviting people to attend the Sandler Training event on February 8th at Ruth Eckerd Hall in Clearwater. Each attendee will receive the benefit of a full day of professional training. Additionally, they'll have an opportunity to network, as well as a chance to learn more about Rotary's leadership in the polio eradication effort. ## SANDLER - POLIO SEMINAR: TWELVE REASONS TO GO

Some have asked, and others have wondered: why are we holding the seminar with Sandler Training Institute? We know we need to raise money for polio eradication and we've already raised a lot. Why bother with something new?

Yes, we have raised a lot of money and we have nearly achieved our district's Gates Challenge fundraising goal. Let me offer twelve reasons why the Sandler Training seminar, to be held on February 8 at Ruth Eckerd Hall, can benefit you and your Rotary Club:

1) If you're a business owner, sales professional, or corporate executive, it's a terrific way to start your year, particularly if:

- Your revenues fell short in 2011 and your business goals and objectives are even higher in 2012
- You're struggling with how to uncover new prospects, increase sales and grow your revenue
- You're frustrated with trying to motivate your people to do more with fewer resources
- You're interested in obtaining referrals and introductions to other business professionals.

2) It's as easy a fundraiser as you'll ever have. All you do is sell tickets, and the tickets should sell themselves.

Your club does fundraisers. They take lots of effort to plan and execute, then to get people to come and spend money. In this case, all of the planning is being done by someone else. All you need to do is get people to buy a ticket and come.

The tickets are \$ 199 in advance (through Friday, January 27). That's a very competitive price for what is being provided. (Typically, full-day training seminars can run anywhere from \$500 - \$3,000)

There's also an incentive to bring a group. If you register five or more people from the same company/organization, the price is \$ 149/person.

3) It's a great way to raise money from non-Rotarians.

So much of the time we go to members of our club with "hat in hand" to raise money. Here's a great opportunity to raise money without all, or maybe even any, of it coming from club members. The following are all good target prospects to attend the seminar:

- a) Business owners (and senior managers of the company)
- b) Sales professionals
- c) Professionals (e.g., lawyers, accountants) who could benefit by learning more about managing their practice, or developing new business.

Members of your club who fit the above profile are excellent prospects, but so, too, are people in your area who aren't Rotarians. Here's an opportunity for local businesses and professionals to accomplish two things simultaneously with the same dollars: 1) obtain professional training; and 2) make a charitable contribution?

4) It's a great way to provide positive exposure for your Rotary Club.

Every club in our district is always looking for new members. Think about leaders in your community that you'd like to get to attend your club. If they haven't visited yet, get them to attend the Sandler seminar. They'll gain a day's worth of excellent training, plus be exposed to Rotary's efforts to eradicate polio. It may give them the necessary impetus to come to your club in the future.

5) It's a benefit to your club members

A key task for leaders of every Rotary Club is to provide greater value to the members. Make it worth their while to continue in Rotary. The Sandler event is an excellent opportunity to provide additional value to your members. Where else can you simultaneously obtain a day's worth of high quality training and, simultaneously, make what you pay a

charitable contribution?

6) It's an opportunity for you to mentor someone in your club or your community.

Your club may already have raised money for the Gates Challenge. Here's a way to make the money you've raised go further. Use it to purchase tickets to the Sandler seminar, then give the ticket to someone in your community, or your club, who might not otherwise be able to attend. What they learn at the seminar could help them advance their careers. The money you've already raised is going to the Rotary Foundation and your club will get credit, so you can make your money "work harder" by also using it to help someone.

7) It can be a way to thank your employees, customers, and suppliers.

Why not purchase tickets for your employees, your customers, even your valued suppliers? Everyone will benefit. Moreover, you can use it as a type of "thank you". In our uncertain economic environment, many people feel insecure. The kind of skills building one can get from the Sandler seminar is a way to help deal with that insecurity.

8) It's a way to increase awareness of polio eradication in your community.

The USA experienced its last polio case some 30 years ago. Polio is effectively invisible to most Americans, something your Rotary Club probably already knows. The Sandler event is a unique way to help publicize Rotary's efforts. Getting people to attend, particularly non-Rotarians, is a good way to increase awareness.

9) It's a way to put money in your pocket.

Everyone who attends the Sandler seminar is bound to learn things they can apply in a timely manner at work. Sales

professionals will sharpen existing skills and may learn new ones. Better skills should translate into higher sales and a higher paycheck. Those in the management seminar will gain/strengthen skills in a way that should help them increase the profitability of their businesses and professions. That should translate into more money in the pocket.

10) It's a networking opportunity for you.

Participants in the Sandler event will have an opportunity to meet new people. Additionally, a networking event will be held immediately afterwards. Here's another opportunity to expand one's network.

11) It's a way to gain a better understanding of your business, your profession, even of yourself.

We often are so busy with our work that we lose the proverbial "forest from the trees". Attending the Sandler event will provide an opportunity to reflect upon your current work, possibly providing new perspective. Doing so can be particularly productive early in the year.
